**2011 INSTALLMENT PLAN**  
**NOTICE: YOU CAN PAY TAXES BY THE INSTALLMENT METHOD**

If you desire to pay **NEXT YEARS** real estate and tangible personal property taxes (2011) by installment, you must file an application with this office **prior to May 1, 2011**. In order to qualify, your 2010 taxes must be more than \$100.00

Applications may be obtained online at [www.sjctax.us](http://www.sjctax.us) or by writing or calling the Tax Collector's Office. Remember, the application must be returned before May 1, 2011 and is for NEXT YEARS taxes.

**IMPORTANT:** The 1st installment is due NO LATER than June 30th, each year, to receive 6% discount. Payment will be accepted in July with no discount and a 5% penalty. NO PAYMENT will be received after July 31 and will be placed on the annual tax payment in November.

PLEASE NOTE: If you are on the installment plan for the current year, you do not need to reapply for next year, you will be automatically reenrolled.
